Kuala Lumpur, 27 Nov 2025 – Bumi Armada Berhad ("Bumi Armada" or "the Group") today announced its third quarter ("Q3") 2025 financial results.

The Group earned net profit<sup>1</sup> of RM96.1 million for the third quarter of 2025 and generated RM170.9 million in net cash flows from operating activities.

Revenue was RM360.7 million and operating profit before impairment was RM135.1 million for Q3 2025. Revenue from the Operations segment amounted to RM356.8 million, a decrease from Q2 2025 mainly due to the absence of a one-off item which occurred in the previous quarter.

The Group maintained a strong cash balance despite reducing debt by US\$89 million throughout the quarter.

The future firm orderbook at the end of Q3 2025 amounted to RM8.6 billion, with additional optional extensions of up to RM9.2 billion.

Commenting on the results, Mr. Gary Christenson, Chief Executive Officer of Bumi Armada said, "These results highlight our continued ability to generate strong cash flows, underpinned by resilient operations and disciplined execution. We will continue to leverage our financial strength to pursue growth opportunities through bidding for new projects and prudent corporate initiatives".
